U.S. CITIZENS CAN STILL SECURE EUROPEAN CITIZENSHIP IN 5 YEARS WHILE LIVING ANYWHERE

If you're a U.S. citizen considering Portugal's Golden Visa, there has never been a more urgent time to act. Portugal is currently the only country in the European Union that guarantees citizenship in just five years after securing residency without the need to live in Portugal full-time.

You can continue living in the United States (or anywhere else in the world), visit Portugal only the seven days per year required to maintain your visa, and at the end of five years, unlock European citizenship for your entire family.



But the clock is ticking: far-right parties are pushing to extend the citizenship timeline to 10 years, with the first parliamentary vote already scheduled for **October 2025**. Those who invest now will secure their status under the current five-year rule. Those who wait may lose the opportunity altogether.
